- Total yield in kilogram
- Varieties of vegetable planted
- Net income Analysis
- 5. Documentation of the benefits of Project WATER 30%
  - For example:
    - -it lessens the consumption of water. They can show their water bill (Before and After pictures/video).
      - Improve the growth of plants. (Before and After pictures/video)
